- At least basic facilitation skills
- Able to communicate in English

# Venue of the training

• The **venue** for the training will be Eco Center Radulovački, Sremski Karlovci (Mitropolita Stratimirovića 5), the only youth center in Serbia with the Quality Label for Youth Centers from the Council of Europe.

accommodation's facilities will be shared bedrooms, up to 3 people per room.
 Food & coffee breaks will be provided by the organisers, offering 3 meals/day.
 We will also provide the dinner on the arrival day and the breakfast on the
departure day.

# Airports closest to Sremski Karlovci are: Belgrade and Budapest (Hungary)

Arriving to Belgrade by plane:

• There are frequent bus and train lines to Belgrade center from where you can take a direct bus / train to Sremski Karlovci.

#### Airport – Belgrade center

#### A1 Mini bus

- Route: Airport Slavija Square
- Approximate travel time 30 minutes
- Get off at Železnička stanica Novi Beograd (Railway station New Belgrade)
- Train and bus stations are minutes away on foot

#### Public Transportation Line 600

- Route: Airport Železnička stanica Beograd
- Approximate travel time 40 minutes
- Get off at Beogradska autobuska stanica (Belgrade bus station) or Železnička stanica Beograd centar (Train station Belgrade center)
- Train and bus stations are minutes away on foot

If there are more of you coming together from Belgrade, there is a possibility to book a car that can drop you off directly to the center at any booked time. The price is 45-55 euro per car. We can book it for you, in case you want to take this option.

### Coming from Budapest

Coming through Budapest airport there is an option to book airport shuttle services that can drop you off directly from airport to Novi Sad. Price per person is 45eur one way. The van drops you off next to main bus station, from where you can take direct bus to Sremski Karlovci. There are buses almost at every 30min, earliest at 4:45, latest at 22:45. Price is 220rsd.
